

## AREC 2021 TERMS & CONDITIONS

### Payment Terms

Full payment must be received at the time of registration to secure your ticket. For online credit card bookings, you will receive an email confirmation with a tax invoice attached. No entry to the event will be permitted for attendees who have failed to pay.

### Cancellations/Refunds

Cancellations can be made up to six weeks prior to the event for the full amount. After this time any cancellation will incur a \$300.00 admin fee. No refunds can be given after two weeks prior to the event; however, substitutions are permitted.

### Tax Deductibility

Conference fees and associated travel costs are normally tax deductible. Eligibility for tax deductions should be verified by your independent tax advisor.

### Program Disclaimer

Speakers and programs are confirmed at the time of publication but are subject to change without notice. In the event that a speaker fails to present at AREC2021 due to illness or unforeseen emergency, TRET will attempt to provide a comparable speaker.
